**Report on CSUL meeting**: Susan Heron submitted a report to TS-PLAN on December 10. CSUL responded favorably to the Cataloger Summit Report but did not have any specific questions or comments. Susan pointed out to them that the SUL catalogers are moving in a positive direction with collaborative efforts underway to standardize practices, mentor, etc. Other news: CSUL did not approve the creation of a PSPC Government Documents Subcommittee; they suggested PSPC form task groups as needed to address documents issues.

**RDA/FRBR presentation**: TSPC voted to schedule a special session to hear USF Dean Bill Garrison's presentation on RDA/FRBR.

### **Report from Shared Bib Pilot Libraries:**

- See the Single Bib swiki for meeting notes and other documentation about the single bib pilot (http://wiki.fcla.edu:8000/SBPP/1)
- The primary merge specification will be the OCLC number.
- Particular record sets may need an alternative merge specification (e.g., CIS). The pilot group is compiling a list of record sets on the swiki. TSPC members are encouraged to add record sets to the list.
- Catalogers may add a subfield 5 with their institution's MARC organization code to fields containing local data but should do so only for data that is institution-specific.

## **FCLA Update**:

- Aleph Services group is moving to another building at FCLA's current location in mid to late December.
- UBorrow is progressing; the pilot group met at FCLA on December 10.
- CSUL accepted the TAG proposal to purchase 16 Elluminate licenses (one for each SUL, five for committee chairs).
- Jean will post an update to TS-PLAN re. the status of incremental bib updating in Endeca.

**Demo of UBorrow interface**: Mary Ann O'Daniel presented the UBorrow test interface. A Get-It button appears on the brief and full views of the record as follows:

- Green Get-It: Item is not available at host institution; user can request from another institution
- Yellow Get-It: Item is available at host institution; user is directed to local item information
- Red Get-It: Item is not available at any institution; user is directed to Illiad

Endeca pulls the available status from the item record. If there is no item record, the Get-It button does not display. TSPC discussed how the Get-It functionality might be adapted to handle in-process requests. FIU, USF, FSU, and FIU expressed interest in meeting separately with FCLA to discuss how in-process requests are currently being handled and possibilities for making improvements. Amy Weiss and Sue Wartzok will schedule the meeting.

**Statewide Standards for MARC Records Advisory Group**: Jane Anne Carey (UF), Charles Gordon (USF), Kim Montgomery (UCF), Tom Tharrington (NCF), Sarah Cohen (FSU), and Daniel Cromwell (FCLA) volunteered to serve on the Advisory Group. TSPC agreed that six members is sufficient. Amy Weiss will draft the group's charge.
