

**TSPC Conference Call 8/3/05  
Minutes**

Preliminary: Martha Hruska noted that the group may need to plan more frequent conference calls between now and the Nov. Joint meeting. She suggested monthly conference calls, proposing a follow-up call in September.

1. **CSUL Restructuring** -- appointments, terms
  - a. Oversight – We have pointed out that the Authority Subcommittee was not included at all in the proposal document. It is expected the Directors will take this up at their Sept. meeting.
  - b. Restructure document includes vice-chairs – TSPC has not had one in recent years.
    - i. The Directors appoint the Chairs, vice-chairs of the committees.
      1. It was suggested that we should give them a slate of possible candidates.
    - ii. Terms for offices? – There was discussion of what that means – maybe 2 years with possible renewal? Or consider going with chair-elect/chair structure. Annual appointments are easier administratively. But we also want to allow for a smooth transition process.
  - c. Vote will be by email on this issue. Martha will summarize and send out options.

**Subcommittees:**

CAGER – has a new acting chair as of August meeting, Naomi Young (UF). The group acknowledged Jim Michael's many years of service as chair

Authorities – has co-chairs, on 2 years then alternate.

Martha Hruska noted that the subcommittees should be structured the same way.

Annual rotation would be an option, since representation doesn't change that often.

2. **Authority support** -- outsourcing interest

Mary Ann reported on last load of 0409 AUTH subject update, this load did link to bibs. UE11 log used as reporting mechanism isn't working – reports every authority, not just the ones that match up. The Authority loads will proceed, since linking is working. FGCU (last of P2Ls) STP is scheduled for 8/8; there will be no auth loads while the STP is in process.

Outsourcing authority work – Aleph performance in this area is disappointing – UF is looking at outsourcing options and costs

The Authority subcommittee will look at vendor options and report back on the conference call in Oct.

Advantages over FCLA/Aleph?

Aleph not doing the reports we had in NOTIS

Reports not well developed

Mary Ann hasn't used Reports/Services module much – “a lot of noise” in Aleph reports

From experience dealing with LTI (one of the possible vendors), it was noted that you get reports of changed headings, records of bibs with

changed headings, with update turned on. You get records flipped, and a report that shows which flips didn't work.  
Problems – UT (Uniform Title), for example – problem with getting records re-loaded into database once LTI does them. GenLoad may not handle it  
Costing – UF has costed out, will send the information to the Authority Subcommittee.

FCLA reception – at FCLA offices – approved

### 4. **Updates**

#### FCLA

Gulf Coast goes live in Aleph 8/8

Phase 3s are done with initial training

#### EDI

Dan North – successful test with Midwest has been completed – sending first live orders 8/4

Setup

TAB35 – normal orders after that, but choose EDI setting instead of print

Choose LE, not LI – run service to send EDI records, goes to vendor as a file, vendor strips their needed data out

Midwest sends back email confirmation

FCLA and Yankee about to start working on Yankee interface

UF has successfully loaded EBSCO invoice.

Continue discussion in September 7 conference call

#### Interinstitutional Aleph access

Daniel Cromwell noted that each Aleph library is separate – from a local Aleph client, one can't go and look at what is done at another institution. You need to set up guest user in the local client to enable other libraries to have view access to the functional modules (Acquisitions, Cataloging, Serials...) Must sign off user name in local client and sign in as guest in the client for the other library you want to check.

It was agreed that we should have the same inter institutional view privileges as we had under LTRF

Z39.50 – works now to derive records from other institutions over Z39.50 if you have that session set up

#### MacroExpress

We have purchased 750 licenses, on top of what libraries already had – Daniel Cromwell will send url to Project Managers list to download, plus name and code for the license. Each institution will need to send the number of licenses they need, through the Project Managers. Details of how the licenses will be monitored still need to be worked out.
