Minutes: Minutes for the February 8, 2011 Authorities Subcommittee Meeting were approved.

#### Subcommittee update:

 Florida NACO Funnel: Priscilla announced that Joy Banks, the former cataloging librarian at Florida Southern College in Lakeland, would like to continue as a Florida NACO Funnel participant in her new job at Bok Tower Gardens. However, she will not have OCLC access so Priscilla checked with PCC and there are some options for her to continue submissions. Joy can either ask her institution to become a PCC member, or Priscilla as Florida NACO Funnel Coordinator (or anyone else in the Funnel) can to submit Joy's NACO authority records to the Authority File. Priscilla is waiting for a response from Joy.

#### FCLA update (Mary Ann O'Daniel)

- UBorrow soft-launch occurred March 1, the day of the meeting. It can be used at this time but is not being widely advertised while FCLA works on any remaining table setup and workflow issues are fixed. Daniel Cromwell is assisting UBorrow clients and was not able to attend the subcommittee call.
- FCLA is working on a beta test to provide access to Ex Libris's Primo Central from Mango. There's no cost to FCLA for this pilot. More about the project can be found at: <u>http://fclaweb.fcla.edu/content/primo-central-beta-test</u>. Several SULs are looking at potentially purchasing other discovery services (FSU, UF, USF, UNF) which would

bypass the Mango interface. There was a brief discussion about centralization of services and the need to coordinate decisions about discovery services across the state, both financially and for access to statewide SUL functions and materials.

#### **Old Business**

- Roster update (Charles Gordon): Charles is clarifying the names of voting representatives from each institution to post on the Authorities Subcommittee section of the TSPC SWiki. Priscilla stated she has turned in some name updates to Sabine Butler (<u>snbutler@fsu.edu</u>) the person maintaining the CSUL website.
